

UNIVERSITY OF THE PACIFIC PHARMACY EDUCATIONAL BACKGROUND CHART

Please follow instructions and fill out all items carefully. This form is an important part of your admissions file and should be an accurate reflection of your academic background. Please account for your time (work experience, travel, job hunting, etc.) if you were not enrolled during the academic year. Be sure to account for each year since graduating high school. Educational Background Charts received with gaps in time will be returned. This may cause you to miss the deadline, as this chart is a required part of the application. We have provided a sample on the other side of this form. Please note that you are required to list schools even if they are unaccredited, technical, or vocational in nature. All transcripts from these types of institutions must be sent directly to Pacific. (PharmCAS only collects transcripts from U.S. and Canadian accredited institutions.)

Please send official transcripts NOT sent to PharmCAS directly to: Office of Admission, University of the Pacific, 3601 Pacific Avenue, Stockton, CA 95211.

- Column 1 - **You must account for every year beginning with your last year in high school.** If you attended a college or university prior to graduating high school, please list the schools in the order you were enrolled. (See example on back)
 If you were out of school for a length of time, it must be noted and you must list the work experience or activity you were involved in. Allow one line for each year. If you attended more than one school in a year, list that year more than once.
It is required that you list ALL colleges, universities, and institutions attended, foreign or domestic, whether the course work fulfills prepharmacy requirements or not. Include the name of all institutions you enrolled in, even if the classes were not completed. Include the names of institutions which you enrolled in by correspondence, extension and summer sessions. Include the name of the institution of current college attendance and course work planned. Official transcripts listed on the chart are required to process your application. All U.S. and Canadian transcripts must be sent to PharmCAS. All transcripts from unaccredited institutions and international transcripts with ECE evaluations must be sent directly to Pacific.
- Column 2 - Enter the name of each school attended. (You are not required to list individual classes.)
- Column 3 - Write the name of the city and country where each school you have attended is located, where you obtained work experience, or where you were involved in other activities.
- Column 4 - Write the name of any internal or external examination(s) you passed or certificates you obtained at the end of that year. For example: if you sat for the General Certificate of Secondary Education (GCSE) at the end of your 11th year in school, on that line write: GCSE.
