**Linda Carter**, Pacific McGeorge School of Law, taught classes in international criminal law at the Cheikh Anta Diop University's School of Law and Political Science in Dakar, Senegal. She also lectured on the Supreme Court of the United States in a comparative law course, and presented "The Development of International Criminal Procedure: The Challenge of Blending Civil Law and Common Law Legal Systems" to the faculty.

**Miriam Cherry** and **Jarrod Wong**, Pacific McGeorge School of Law, had their article "Clawbacks: Prospective Contract Measures in an Era of Excessive Executive Compensation and Ponzi Schemes" accepted for publication in the *Minnesota Law Review*.

**Fred Galves**, Pacific McGeorge School of Law, had his interactive casebook "Evidence: A Contemporary Approach" published by West. His co-authors were Dean Sydney Beckman of the Lincoln Memorial School of Law and Professor Susan Crump of South Texas College of Law.

**Frank Gevurtz**, Pacific McGeorge School of Law, taught a course on Administrative Law in Guangzhou, China as part of the school's USAID-funded "Partnership in Experiential Legal Education Program."

**Peter Hilsenrath**, Eberhardt School of Business and Thomas J. Long School of Pharmacy and Health Sciences, will be presenting "Gasoline Prices and Their Relationship With Rising Motorcycle Fatalities, 1990–2007" at the 7<sup>th</sup> World Congress on Health Economics in Beijing. He will also discuss "Finance, Efficiency and Performance in Health Care Organizations" at the Academy of Management Annual Meeting in Chicago.

**Bruce La Brack**, School of International Studies, Emeritus, chaired an Expert Speaker's session on "Emotional Intelligence and Diversity;" presented at a session on "Cyber-Learning Courses to Enhance Study Abroad: Challenges and Opportunities;" was a respondent at the "Seminar on Critical Thinking Rubrics" and presented at the session on "Study Abroad for Global Engagement Research: The Long-Term Impact of International Experiences," all at the 61<sup>st</sup> Annual NAFSA-Association of International Educators Conference in Los Angeles.

Four athletes from Pacific Men's Volleyball earned 2009 MPSF All-Academic Honors: **Jeff Hendershot '09**, **Kevin Pratte '09**, **Mark Bauhs '10** and **Clay Ostrander '10**.

**Steve McCaffrey**, Pacific McGeorge School of Law, argued for the Nicaraguan legal team in a dispute over control of the San Juan River at the International Court of Justice in The Hague, Netherlands. He spoke on global health in the context of water resources at the international, state and local levels at a meeting of Sacramento chapter of the World Affairs Council at the U.C. Davis School of Medicine. McCaffrey visited Palestine for a meeting of the water team that advises the Palestinian National Authority in preparation for negotiations with Israel.

**John Myers**, Pacific McGeorge School of Law, participated in six workshops in a conference on "Advanced Forensic Interviewer Training" sponsored by the National Children's Advocacy Center in Huntsville, Ala. He conducted workshops on evidence issues, recent developments relevant to investigation, child witnesses, and evaluation of psychological evidence at the Clackamas County Sheriff's Child Abuse & Family Violence Summit in Portland, Ore.

**Tim Naccarato**, Pacific McGeorge School of Law, was honored in May in Sacramento as the 2009 Teacher of the Year for his work in the Protect and Defend Constitutional Project, which sends teams of judges, attorneys and law professors into high school civics classes to talk about the American legal system.

**Paul Paton**, Pacific McGeorge School of Law, lectured on "SEC Prosecutions of Lawyers Post-Enron: Stock-Option Backdating and other Cautionary Tales" as the featured speaker of the University of British Columbia Faculty of Law's National Centre business law luncheon in Calgary, Alberta.

**Cathy Peterson**, Thomas J. Long School of Pharmacy and Health Sciences, had her article "Humanitarian Partnerships, Physical Therapy Students and Faculty Making a Difference" published in *The Internet Journal of Allied Health Sciences and Practice*.

**Colleen Truden**, Pacific McGeorge School of Law, spoke on "Heating up Your Search: Alternative Career Paths in a Cooling Economy" at a Bay Area Legal Recruiting Association conference in San Francisco.

In March, **Pacific McGeorge's Institute for Administrative Justice** was awarded a four-year contract by the California Department of Corrections and Rehabilitation to provide legal representation to juvenile offenders in parole revocation hearings. This contract is in addition to the contract awarded earlier this fiscal year to provide legal representation to adults in parole revocation hearings.

Pacific McGeorge students **Allysia Holland '09** and **Preston Morgan '09** won the national title in the championship round of the prestigious 18<sup>th</sup> Annual Saul Lefkowitz Moot Court Competition in Washington, D.C. Competing with more than sixty teams of law students in the national competition, the Pacific McGeorge team was one of four regional winners at the event held at the U.S. Court of Appeals for the Federal Circuit. Holland and Morgan also won the Best Oralist Team award and \$5,000 in cash prizes.

Pacific's student chapter of the American Marketing Association (PAMA) partnered with the Miracle Mile Improvement District in April to host the "Prowl'n the Mile" street fair. The event raised a total of \$1,000 to help send El Dorado School 5<sup>th</sup> graders to Science Camp. **Sacha Joseph-Mathews**, Eberhardt School of Business, **Keith Hatschek**, Conservatory of Music, with PAMA officers **Jessica Safir '10**, **Jason Roth '09** and **Chelsea Gomes '10**, presented the proceeds to the students at the school in May.

## BEST IN THE NATION GOES TO BRUBECK QUINTET

For the second time in three years, Downbeat Magazine named the Brubeck Institute Jazz Quintet the best college jazz group in the nation. The award was announced in the June edition of Downbeat Magazine, the 32<sup>nd</sup> Annual Student Awards issue. The group received the same honor in 2007.

The Brubeck Institute Jazz Quintet performs about 25 concerts each year around the United States. “This is a great honor and one that is well deserved by the fellows because they work hard to bring the best jazz, both standards and new creative works, to audiences around the nation,” said Steve Anderson, director of the Brubeck Institute.

The 2008–2009 fellows are saxophonists Ben Flocks from Santa Cruz, Calif., saxophonist Chad Lefkowitz-Brown from Horseheads, N.Y., pianist Javier Santiago from Minneapolis, Minn., bass player Zach Brown from Columbia, Md., and drummer Adam Arruda from Toronto, Canada.
