



PROVOST SEARCH UNDERWAY

The search process to fulfill the position of Provost is now well underway. President Eibeck appointed a search committee and the University has engaged the search firm of Isaacson, Miller to assist in the process. Open forums were held in October at all three campuses to provide feedback to the search firm.

Over the next several months, a Prospectus on the University and a job description of the Provost role will be developed and used to market the position. Advertisements, networking and personal contacts will be used to attract a well-qualified and diverse applicant pool. The committee feels very strongly that this is a unique time to be looking for a Provost and that Pacific is well-positioned to be an attractive environment for an academic administrator.

The search committee is in the process of developing a special webpage to advertise the position, provide informational updates and a method for submitting nominations. This site will be advertised upon the completion of the position profile.

Nominations are also being accepted from the Pacific community. Please consider nominating people that you know and feel would be an appropriate candidate to be Pacific's next Provost. KEEP IT! consensual! EVENT EXCEEDS EXPECTATIONS

The "Keep it Consensual" symposium on October 29, designed to raise awareness of the problem of sexual assault, drew nearly 1,000 participants. "The day met and exceeded our learning outcomes and high expectations," says Vice President for Student Life Elizabeth Griego. "I feel very confident that we raised awareness and that we sparked some good thinking on this important issue."

Throughout the day, students, faculty, staff and community members participated in sessions covering sexual assault, the nature of consent,

aspects of rape law, bystander empowerment and support of victims, best practices in responding to sexual violence, and more. At the powerful keynote session with guest speaker Brett Sokolow, "Drunk Sex or Date Rape," about 700 students were actively involved in the discussion of an actual sexual assault case from 12 years ago.

For the first time, staff members twittered the sessions live. There were many appreciative responses from both college and high school students and other colleges to the "tweets." Raquel Aldana, Pacific McGeorge School of Law, was an organizer of the LatCrit XIV conference held in Washington, D.C. She was a panelist for “Latino Electoral Politics and Immigration Reform: An Assessment of the Obama Administration” and also participated in the conference’s new teacher’s development workshop.

George Condon, Jacoby Center for Public Service & Civic Leadership, organized the program “Why go to college?” for students and their families in the Ripon Unified School District to increase awareness of college opportunities and promote enrollment in local universities within the rural population of San Joaquin County. MEDICARE PART D INFORMATIONAL EVENTS SPONSORED BY STUDENT PHARMACISTS

Beginning November 15, Pacific pharmacy students will conduct community outreach events to assist individuals on Medicare to enroll into the appropriate Medicare prescription drug plan. At many of the events, they also will offer free health screenings for glucose, cholesterol and bone density, and provide information on different health-related topics. The students can accommodate seniors who speak Vietnamese, Mandarin, Cantonese, Spanish and Korean, among other languages.

During last year's enrollment period, students assisted 315 Medicare beneficiaries, saving them an estimated \$145,000 of the costs they would have spent on prescription drugs or inappropriate premiums. Since prescription drug plans can change from year to year, Medicare beneficiaries are encouraged to review their plans each year.

Those attending should bring their Medicare card and all of their prescription medications. If you have friends or family who can benefit from this assistance, let them know the time and location of the events near them:
