

8...SUSPICIOUS INCIDENT ATCHLEY WAY 040907

Officer contacted a male subject going through the dumpster. Subject was interviewed, revoked from campus and advised of trespassing laws.

9...ARREST BROOKSIDE & MANCHESTER 041007
