1...CASUALTY DEPT OF PUBLIC SAFETY 081207

Officer reported feeling ill after a battery exploded while charging. Medics responded and transported the officer to a local hospital.

Staff reported an elder female with chest pains. Officers and medics responded. Subject was transported via ambulance to a local hospital.

10...SUSPICIOUS INCIDENT STAGG MEMORIAL STADIUM 081507

Staff reported two subjects going into the stadium. Subjects were previously arrested for vandalism and trespassing. Subject were warned and released.
