#### Stockton Specific - AWARD DESCRIPTIONS AND CRITERIA

#### ELIZABETH GRIEGO OUTSTANDING STUDENT LEADER AWARD

This award recognizes a graduating senior (92 units or more) and is presented at the all-university commencement ceremony.

# <u>Strong nomination letters should include evidence of the following:</u>

- Sustainable contributions that have significantly improved the student experience.
- Demonstrated outstanding scholarship and service to the campus community.
- Supported by at least two letters outlining the impact of the nominee's broad involvement.

#### **JUDY CHAMBERS LEADERSHIP AWARD**

This award recognizes an ASUOP Officer for their outstanding positive impact on the campus community in their first year of involvement with ASUOP.

# Strong nomination letters should include evidence of the following:

- Demonstrated a strong commitment to leadership that influenced positive change.
- Letter of support from peers outlining the impact of the nominee's service.

#### JESSE MARKS CO-CURRICULAR AWARD

This award recognizes a graduating senior (92 units or more) who has made significant and outstanding contributions to the university.

### Strong nomination letters should include evidence of the following:

- Significant involvement in organizations and activities outside of the classroom.
- Involvements have positively impacted the campus community in significant, meaningful ways.

### NORM ALLEN OUTSTANDING STUDENT LEADER AWARD

This award recognizes an ASUOP Officer who models a commitment to improving the Pacific student experience and demonstrated passion for diversity, equity, and inclusion through peer empowerment.

# Strong nomination letters should include evidence of the following:

- Served as a positive role model for others and worked collaboratively with peers.
- Advocacy that addressed diversity, equity and/or inclusion.
- Letter of support from peers outlining the impact of the nominee's service.

#### STUDENTS SERVING STUDENTS ADVOCACY AWARD

This legacy award recognizes an ASUOP officer who has demonstrated passion for cultivating a meaningful, intentional, and memorable Pacific student experience.

#### Strong nomination letters should include evidence of the following:

- Demonstrate collaboration with other clubs/organizations/departments and involvement with the campus community in positive programs and activities.
- Letter of support from peers outlining the impact of the nominee's service.

# STUDENT EMPLOYEE OF THE YEAR AWARD

This award recognizes a student employee who inspired, influenced, and conducted themselves in a professional manner, acting as a role model for others while making exceptional contributions in their department and the wider university community.

# <u>Strong nomination letters should include evidence of the following:</u>

- Demonstrated a strong commitment to leadership that influenced positive change in their department and the wider university community.
- Served as a positive role model for others and worked collaboratively with those outside of their department.
- Letters of support from your immediate supervisor(s) and co-workers outlining the impact of the nominee's service.

# FRATERNITY & SORORITY LIFE MEMBER OF THE YEAR AWARD

This award recognizes an outstanding member of an FSL organization who has demonstrated their commitment to the continued success of the larger FSL community at Pacific.

## Strong Nomination letters should include evidence of the following:

- Demonstrated academic, philanthropic, and leadership within their chapter or respective council, if applicable.
- Demonstrated advancement of the FSL community at Pacific.
- A written letter of support from their chapter, confirming that this member is in good standing with their affiliated chapter(s) and inter/national organization.
- Provide a written statement of how their FSL membership has enhanced their time as a student at Pacific.
- Must be in good standing with Pacific.

### DOCHTERMAN OUTSTANDING JUNIOR SCHOLARSHIP

This scholarship recognizes a student with junior standing who has made significant contributions to the university. Junior standing is considered between 56 -92 units or in the fourth year of a five-year program.

### <u>Strong nomination letters should include</u> evidence of the following:

- Demonstrated leadership in the classroom through strong academic achievement and involvement.
- Served as a positive role model for others outside of the classroom and works to influence positive change in the university community.

### FRATERNITY & SORORITY LIFE CHAPTER OF THE YEAR AWARD

This award recognizes the outstanding achievements of an individual chapter to the larger FSL and Pacific community. This chapter has demonstrated their commitment to excellence both on and off campus through various achievements, including high academic standards, philanthropic efforts, collaboration with other organizations and leadership through their membership.

### Strong nomination letters should include evidence of the following:

- Positive contributions they have made to the larger FSL, Pacific, or Stockton communities.
   Include an outline of their achievements for the current academic year.
- Share any inter/national awards or recognitions they have received from inter/national organizations during the current academic year.
- All eligible organizations must be in good standing with their respective governing councils, if applicable, the Office of Fraternity and Sorority Life and Pacific.

#### FRATERNITY & SORORITY LIFE PRESIDENT OF THE YEAR AWARD

This award is presented to an individual who has made outstanding contributions to their fraternity or sorority chapter under their direct leadership. This member has shown a balance of academics, philanthropic efforts, commitment to their chapter's growth, and be in good standing. This member is an ethical and honest leader who has committed themselves to the advancement of the FSL community.

#### Strong Nomination letters should include evidence of the following:

- A minimum of 2 months served as the president of their organization at the time of submitting their application.
- · Demonstrated commitment and efforts of the advancement of their chapter or larger FSL community.
- A written statement defining what leadership means to the nominee and how they have demonstrated this definition or qualities during their time as an FSL president.
- A written letter of support from their chapter or respective council, if applicable, or on-campus advisor, if not a part of a council.

#### ANDERSON Y COMMUNITY SERVICE AWARD

This award recognizes an outstanding registered student organization engaged in the Pacific and surrounding local community.

#### Strong nomination letters should include evidence of the following:

- Routinely engaged in ongoing community service.
- Organization action and activities which exemplified and supported the mission of Anderson Y, to empower others and build a healthy community.
- One letter of support from a community-based organization outlining the impact of the nominee's service.

### THE CHAMPION OF DIVERSITY, EQUITY, AND INCLUSION AWARD

This award recognizes a student who has gone above and beyond in their support of DEI efforts and exemplifies the university's value of DEI in an exceptional manner.

#### <u>Strong nomination letters should include evidence</u> of the following:

- Inclusive leadership that fostered positive interaction between people of different backgrounds and other identities.
- Advocacy that addressed diversity, equity and/or inclusion concerns.
- Participated in or facilitated the development and/or implementation of a new program or reimagined/updated an existing program to enhance DEI within a department, division, club or organization, or university-wide.
- Listing of any university committee(s) or student club/org(s) the nominee is actively involved in at Pacific that have focused on addressing issues of diversity, equity, and inclusion.

#### PACIFIC TIGER AWARD

This award is presented annually by the Pacific Alumni Association to recognize a registered student organization that exhibits extraordinary school spirit, encourages student participation in activities and events, promote school spirit, and/or provides students with knowledge of Pacific's heritage, traditions, and history.

Responsible Leadership at Pacific is the ethical act of inspiring others towards the accomplishment of a common goal.

# OUTSTANDING GRADUATE STUDENT LEADER AWARD

This award recognizes a graduating graduate student who has made significant contributions to the university.

#### <u>Strong nomination letters should include</u> evidence of the following:

- Demonstrated leadership in the classroom by positively influencing peers.
- Has begun making a significant contribution to their field through excellence in research, service, programming, etc.
- Served as a positive role model for others outside of the classroom and works to influence positive change in the university community.

### OUTSTANDING STUDENT ORGANIZATION ADVISOR AWARD

This award recognizes an advisor who has provided significant assistance towards advancing the goals and mission of a registered student organization.

#### Strong nomination letters should include evidence of the following:

- Demonstrated a strong commitment to a registered student organization which has resulted in student growth and development.
- Actively assisted in the navigation and interpretation of university policies and procedures.
- Participated as an advisor supporting the university mission statement to develop practice-ready graduates.

#### STUDENT ORGANIZATION OF THE YEAR AWARD

This award recognizes a registered student organization who has made a lasting impact on the Pacific community.

#### Strong nomination letters should include evidence of the following:

- Visibility on campus and recognized/ respected for providing quality programs, services, and/or experiences to its members and the campus community.
- Collaborated with other clubs/organizations and involves the campus community in positive programs and activities.
- Promoted Pacific's definition of responsible leadership through involvements and actions.
