Annual California Campus Safety Plan Report

We want to take this opportunity to thank the campus community for helping keep Pacific a safe campus. Please take the time to read this year's annual California Campus Safety Plan report. The report offers you essential information about campus security practices and efforts and how you can follow personal safety best practices while on the University of the Pacific campuses. This report is broken into three sections addressing the specific safety practices for each of our three campuses in Sacramento, San Francisco, and Stockton. The Department of Public Safety designed this report to comply with the California State Education Code, Chapter 16, of the Donahue Higher Education Act, found at Sections 67380 et seq. All California higher educational institutions are mandated to collect reports of incidents and arrests for Part I crimes of willful homicide, rape, robbery and aggravated assault as well as crimes occurring on campus that involve violence, hate violence, theft, destruction of property, illegal drugs and alcohol intoxication committed on campus the previous calendar year. This report in support of California law is separate from the Annual Security Report (ASR) required under the federal Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act (the Clery Act).

Keeping the university safe is a collective and continuous responsibility. We have learned over time that the best protection is to be aware and "If You See Something, Say Something." We hope the information provided in this report will assist you in staying safe.

Sacramento Campus

1 Department of Public Safety Authority and Jurisdiction Policy Statement

The University of the Pacific, Sacramento Campus operates under a "Memorandum of Understanding" ("MOU") with the City of Sacramento, which defines the authority and jurisdiction of all public safety officers of the University of the Pacific Sacramento Campus Department of Public Safety. Sacramento public safety officers are not sworn police officers although they have powers of arrest through California Penal Code section 830.7(b), Penal Code 836, and the MOU with the Sacramento Police Department. Public safety officers have the authority to carry weapons while on duty. Additionally, the officers are required to

maintain current California Department of Consumer Affairs, Bureau of Security and Investigative Services (BSIS) Guard permits, firearms open carry permits, chemical agents permits and baton permits. Officers have completed either the POST basic peace officer training academy's reserve officer level modules or a minimum PC 832 Powers of Arrest training.

The primary responsibility of the Department of

Public Safety is the protection of the Sacramento Campus community. The current MOU identifies the Sacramento Campus' jurisdiction and campus perimeter as: Sacramento Campus property, including land, structures, streets, roadways and parking lots. The Sacramento Campus is bordered on the east side by McClatchy Park and 33rd Street from Fifth Avenue to Montgomery Way. The south border is Montgomery Way from 33rd Street to 32nd Street. The west border is the freeway wall from Montgomery Way to Fifth Avenue. The northern boundary spans three blocks from the freeway east to 35th Street. The boundary includes the alley just north of Fifth Avenue from 32nd Street to 33rd Street and the alley north of Marshall Way from 33rd Street to 34th Street. The Sacramento Campus also includes the university building and adjoining parking lot on Fifth Avenue between 34th Street and 35th Street.

Through the MOU with the Sacramento Police Department, felony and identified misdemeanor crimes (such as misdemeanor sexual crimes) that occur within the identified campus boundary are investigated by the Sacramento Police Department. The Sacramento Police Department provides 911 dispatch services for the Department of Public Safety through our patrol radios.

2 Security and Access to Campus

University of the Pacific is a private institution of higher education. The university's Sacramento Campus is open to students, parents, employees, contractors, guests and invitees. The university reserves the right to remove individuals determined to be a threat to the safety of or a disruption to the campus community. University buildings have separate office and building access hours. The majority of office hours are from 8 a.m. -5 p.m., Monday to Friday during the academic year. Contact each department for specific hours of access and restrictions. Building hours vary by facility, depending on the services provided. Evening and weekend access is generally limited to scheduled facility events. Library services and other student resources may also be open to students during evening and weekend hours. University officials and Public Safety officers have the authority to ask for the identification of any individual on campus. Individuals who do not have a legitimate purpose for being on campus can be asked to leave, and if they do not cooperate, may be issued a criminal trespass citation.

Residential halls are secured 24 hours a day and are accessible only through access cards issued to individual resident students. All other facilities will be locked whenever possible, depending on use and scheduling.

The University of the Pacific community strives for a safe and secure campus, including our academic buildings and residence halls. We can only do this with the help and cooperation of all faculty, staff and students. Public Safety officers regularly patrol the campus 24 hours a day. Nevertheless, it is essential for you to be alert and aware of your surroundings and exercise personal safety.

Below are actions that should be practiced daily to ensure everyone's safety:

- Do not prop exterior doors; this allows for easy access to unwanted strangers.
- Do not hold the door for strangers.
- A stranger should be asked to use their access card or to call the person they visit to come and let them in.
- If you see suspicious activity, notify security immediately.

3 **Reporting of Crimes**

Whether it happens to you or you are a witness, you are strongly encouraged to report any crime in a timely manner. If a crime occurs on or around campus, report it immediately to the Department of Public Safety. Timely reporting of information helps us in deterring crime and protecting the campus community from ongoing threats. Please do not delay in calling. 4 Crime Prevention Programs and Services Available

5 Action Taken in the Last 18 Months to Increase Safety

University of Pacific continually looks to improve the safety of the Sacramento Campus. The Campus Safety and Security Committee continually evaluates the campus's security needs and identifies resources to resolve any security concerns. Over the past 18 months, the university has completed the following to increase security on campus.

- Active shooter preparedness training was presented to the campus faculty and staff.
- Public Safety officers attended de-escalation, DEI, Implicit Bias and Tactical Communications training.
- Two new 360 pan and tilt cameras were added, replacing aging cameras in parking lots.
- Monthly safety reports continue to be sent out to all students, faculty and staff, advising of crimes or incidents on campus and providing safety information.
- A new fire alarm system was installed in one of our campus residence buildings as part of a campus-wide fire system refresh.
- Additional monitors were added to expand viewing capabilities for campus CCTV coverage.
- Laptops were added for officers to use in the field or vehicles to access the university's camera system.
- The Department of Public Safety implemented a fixed post in our dental clinic for the safety of students, staff, faculty and patients.

6 Actions Planned for the Next 24 Months to Increase Safety

- Continue officer training, education and development regarding current issues in the community to ensure proper responses and the handling of sensitive, delicate or volatile situations.
- Active shooter response training for Public Safety officers.
- Coordinate training with local law enforcement agencies to better familiarize and educate university officers for responding to mutual aid and multi-agency situations.
- Purchase additional video surveillance cameras for parking lots and campus building coverage.
- Continue to increase officer staffing for better campus coverage, responding to incidents and crimes, officer safety and protection of the campus community.
- Coordinate with the campus housing manager and continue to engage in functions and activities with students who reside on campus.

• Continue to have representation at campus events that include all departments and programs, to provide opportunities for the campus community to engage with our department and get better acquainted with our officers.

1 Department of Public Safety Authority and Jurisdiction Policy Statement

Department of Public Safety officers at the University of the Pacific's San Francisco Campus are licensed security guards employed by the university. Each public safety officer possesses a professional license issued by the California Department of Consumer Affairs and has completed the requisite training and certification required for licensure. Public Safety officers are empowered with private person's arrest authority pursuant to California Penal Code section 837. They are authorized to make arrests for any offense committed in their presence and for felony offenses not committed in their presence when there is reasonable cause for believing the person arrested committed the crime. The San Francisco Campus's Public Safety officers are not sworn peace officers, and they do not have the authority to pursue crime off-campus. STheir jurisdiction is restricted to the facility located at 155 5th Street. They are authorized to carry weapons while on duty. All officers maintain current California Department of Consumer Affairs, Bureau of Security and Investigative Services Guard permits, exposed firearms permits, chemical agents permits and baton permits. Public Safety officers have completed PC 832 Powers of Arrest training.

All crimes reported to the Department of Public Safety are documented and, where appropriate, reported to the local San Francisco Police Department district or other appropriate law enforcement agency.

All students, faculty and staff are strongly encouraged to make prompt and accurate reports of crimes to representatives from the Department of Public Safety. They are reminded of this during yearly orientation. Prompt and accurate reporting best equips Pacific to keep accurate records of criminal activity to determine whether there is a crime pattern concerning a particular location, method or assailant, and alert the campus community to potential danger.

2 Security and Access to Campus

University of the Pacific is a private educational institution and access to its San Francisco Campus buildings and grounds (located at 155 Fifth Street, San Francisco, CA 94103) are monitored by an access control system activated by personal ID badges issued to each student and Pacific employee. All badges are worn on the outermost garment, attached above the waist with the picture visible. These serve to identify community members to each other and to our patients and visitors. The absence of an ID badge quickly identifies a patient or visitor and expedites patient services.

The San Francisco Campus provides general access to the Pacific community members and their guests between 6:30 a.m. and 11 p.m. during the academic week and between 6:30 a.m. and 9 p.m. on weekends and holidays.

Armed Department of Public Safety officers are on duty 24 hours a day. Security is further enhanced by extensive recorded camera coverage and alarm systems. Public Safety officers remain in the building after general access hours to ensure a continuing security and safety program.

The Union City Dental Care Center is an off-campus facility established to provide hands-on clinical training. The facility is operated in the same way as a professional clinic business. Faculty, staff and students are identified by ID badge and the facility is protected during business hours by private security guards not affiliated with the Department of Public Safety.

University of the Pacific strives for safety on the Sacramento Campus including security in our building. We can only do this with the help and cooperation of all faculty, staff and students.

Below are actions that should be practiced daily to ensure everyone's safety:

- Do not prop exterior doors; this allows for easy access to unwanted strangers.
- Do not hold the door for strangers.
- A stranger should be asked to use their access card or to call the person they visit to come and let them in.
- If you see or hear suspicious activity, notify Public Safety immediately.

5 Actions Taken in the Last 18 Months to Increase Safety and Security

The San Francisco Campus Department of Public Safety continually seeks to improve the safety of the campus. The Public Safety Advisory Committee continually evaluates the campus's security needs and identifies resources to resolve security concerns. Over the past 18 months, the university has completed the following to increase security on campus:

- Continue to partner with the Office of Student Services to present in-person campus safety presentations and guest speakers for the campus community.
- A new emergency paging system utilizing updated technology remains in the process of being obtained to improve emergency medical response to our clinics.
- Hired one new campus safety specialist position on the San Francisco Campus to help with DPS staffing needs and services.
- Hired one additional patrol officer to fulfill staffing shortage.
- All officers were assigned body worn cameras which are used daily.
- Two officers participated in train-the-trainer de-escalation and diversity training and they will provide this training to all members of the Department of Public Safety.
- Hosted a Campus Community Day event with 12 with local and regional service providers.
- Collaborated with on-site medical response personnel to upgrade equipment and response protocols for medical emergencies, including the training of student doctors and their inclusion in the response protocols (continual).
- Continually provide campus safety orientations to incoming classes and new employees.

6 Actions Planned for the Next 24 Months to Increase Safety

- Officers to be trained by in house medical staff in the use of Naloxone for the response, treatment and recovery of an opioid overdose on campus (in progress).
- "Stop the bleed" kits to be placed on all floors and will be provided to patrol officers and dental students by a certified faculty instructor.
- Work with administration on the expansion of the dental school and plan for the expanded security and safety needs of our campus community.
- Continue to secure funding for a security camera update project to be included with the expansion planning of the San Francisco Campus.
- Work with the City of San Francisco to locate a set of bike 'hangars' for secure bicycle storage for our patients.

Department of Public Safety Authority and 1 **Jurisdiction Policy Statement**

University of the Pacific operates under a "Memorandum of Understanding" ("MOU") with the City of Stockton, which defines the authority and jurisdiction of all Pacific Department of Public Safety officers. The MOU appoints these officers as sworn peace officers and thusPacific Public Safety officers have the same powers and authority as any city, county or state law enforcement officer. Their powers include full arrest authority within their jurisdiction as provided by Penal Code section 830.6(a)(2) and the authority to carry weapons while on duty.

The Department of Public Safety's primary responsibility is the protection of the university community. However, through the MOU, the Department of Public Safety has been granted jurisdiction to patrol and police additional specific off-campus areas in the university's vicinity. These areas are frequently traveled by members of the campus community and include residential neighborhoods that are highly populated by the Pacific students, faculty and staff. The current MOU extends Public Safety officers' jurisdiction beyond the campus perimeter to the three-city block area bordered by El Dorado Street, Rosemarie Lane, Bristol Avenue and Grange Avenue that surrounds the University campus. Pursuant to Penal Code section 830.1(a)(2), all Pacific Public Safety officers have the authority to patrol and make arrests both on campus and within this additional jurisdictional area. In addition, university peace officers have the authority under California Penal Code section 830.1(a)(3) to pursue and/or apprehend suspects outside of these designated areas when there is probable cause to believe a public offense has been committed in the officer's presence and there is an immediate danger to person or property or the risk that the perpetrator will escape. Public Safety officers will respond to all emergency calls on or near the campus. Those calls that are determined to need extensive investigations (i.e.: homicides, sexual assaults, fatal accidents) will be handled by Stockton Police Department investigators.

The continuing goal of the University of the Pacific Department of Public Safety is to work cooperatively with the City of Stockton Police Department to ensure the safety and security of all campus community members. Please visit us at
