#### Annual California Campus Safety Plan Report

We want to take this opportunity to thank the campus community for helping keep Pacific a safe campus. Please take the opportunity to read this year's annual California Campus Safety Plan report. The report intends to offer you essential information about campus security and how you can stay safe while at any of the University of the Pacific campuses. The Department of Public Safety designed this report to comply with the California State Education Code, Chapter 16, of the Donahue Higher Education Act, Section 67380. AB 1433 amended sections of the California Education Code found at Sections 67380 et seq. – the student safety provisions. All California higher educational institutions are mandated to collect reports of incidents and arrests for Part I crimes of willful homicide, rape, robbery, and aggravated assault as well as crimes occurring on campus that involve violence, hate violence, theft, destruction of property, illegal drugs, and alcohol intoxication committed on campus the previous calendar year. This report does not meet the requirements of the Annual Security Report (ASR) required under the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act (the Clery Act) but is a separate report to fulfill the requirements of the California law.

Keeping the university safe is a collective responsibility. We have learned over time that the best protection is to be aware and "If You See Something, Say Something." We hope the information provided in this report will assist you in staying safe.

# 1 Department of Public Safety Authority and Jurisdiction Policy Statement

The University of the Pacific, Sacramento Campus operates under a "Memorandum of Understanding" ("MOU") with the City of Sacramento, which defines the authority and jurisdiction of all public safety officers of the University of the Pacific, Sacramento Campus Department of Public Safety. Public safety officers are not sworn. They have full police powers of arrest through California Penal Code section 830.7(b), Penal Code 836, and the MOU with the Sacramento Police Department. All public safety officers have the authority to carry weapons while on duty. Additionally, all officers are required to maintain the current California

Department of Consumer Affairs, Bureau of Security and Investigative Services (BSIS) Guard permit, firearms open carry permit, chemical agents permit, and baton permit. Officers have completed either the POST basic peace officer training academy, reserve officer level modules, or completed a minimum PC 832 Powers of Arrest training.

The primary responsibility of the University of the Pacific, Sacramento Campus Department of Public Safety is the protection of the Sacramento campus community. The current MOU identifies the University of the Pacific's Sacramento campus's jurisdiction and campus perimeter as: Sacramento Campus property, including land, structures, streets, roadways, and parking lots. The Sacramento campus is bordered on the East side by McClatchy Park and 33rd Street from Fifth Avenue to Montgomery Way. The South border is Montgomery Way from 33rd Street to 32nd Street. The West border is the freeway wall from Montgomery Way to Fifth Avenue. The Northern boundary spans three blocks from the freeway East to 35th Street. The boundary includes the alley Just North of Fifth Avenue from 32nd Street to 33rd Street and the alley North of Marshall Way from 33rd Street to 34th Street. The Sacramento campus also includes the university building and adjoining parking lot on Fifth Avenue between 34th Street and 35th Street.

Through the MOU with the Sacramento Police Department, felony and identified misdemeanor crimes (such as misdemeanor sexual crimes) that occur within the identified campus boundary are investigated by the Sacramento Police Department. The Sacramento Police Department provides 911 dispatch services for the Department of Public Safety through our patrol radios.

#### 2 Security and Access to Campus

The University of the Pacific, Sacramento Campus is a private institution of higher education. The Sacramento campus is open to students, parents, employees, contractors, guests, and invitees. The University reserves the right to revoke individuals determined to be a threat to the safety of or a disruption to the campus community. University buildings have a separate office and building access hours. The majority of office hours are from 8:00 a.m.-5:00 p.m., Monday-Friday during the academic year. Contact each department or building for specific hours of access and restrictions. Building hours vary by facility, depending on the services provided. Evening and weekend access is generally limited to scheduled facility events. Library services and other student resources may also be open to students during evening and weekend hours. University officials and Public Safety have the authority to ask for the identification of any individual on campus. Individuals who do not have a legitimate purpose for being on campus can be asked to leave, and if they do not cooperate, may be issued a criminal trespass citation.

Residential halls are secured 24 hours a day and are accessible only through access cards issued to individual resident students. All other facilities will be locked whenever possible, depending on use and scheduling.

The University of the Pacific Community strives for a safe and secure campus in our academic buildings and residence halls. We can only do this with the help and cooperation of all faculty, staff, and students. Public Safety Officers regularly patrol the campus 24 hours a day. Nevertheless, it is essential for you to be alert and aware of your surroundings and exercise personal safety.

Below are actions that should be practiced daily to ensure everyone's safety:

- Do not prop exterior doors; this allows for easy access to unwanted strangers.
- Do not hold the door for strangers.
- A stranger should be asked to use their access card or call the person they visit to come and let them in.
- If you see suspicious activity, notify security immediately.

## **3 Reporting of Crimes**

Whether it happens to you or you are a witness, you are strongly encouraged to report any crime in a timely manner. If a crime occurs on or around campus, report it immediately to the University of the Pacific, Sacramento Campus Department of Public Safety. Timely reporting of information helps us in deterring crime and protecting the campus community from ongoing threats. Please do not delay in calling. #### 5 Action Taken in the Last 18 Months to Increase Safety

The University of Pacific Sacramento Campus continually looks to improve the safety of the campus. The Campus Safety and Security Committee continually evaluates the campus's security needs and identifies resources to resolve any security concerns. Over the past 18 months, the University has completed the following to increase security on campus.

- Department of Public Safety added 4 new surveillance cameras to the campus for increased camera coverage.
- Updated department and parking signage throughout campus to help better identify parking lots, location, and public safety contact information.
- Updated the video surveillance system with an additional monitor and new CPU.
- Public Safety and Student Life continues its educational outreach efforts related to recognizing, preventing, and responding to acts of campus violence.
- Established direct communication with Oak Park security patrol officers for issues and information regarding the campus areas to create a partnership and safer environment for the campus community.

# 6 Actions Planned for the Next 24 Months to Increase Safety

- Increase officer staffing for better campus coverage, responding to incidents and crimes, officer safety, and protection of the campus community.
- Issue and deploy newly acquired body cameras for individual officers for more accurate documentation of incidents/crimes and increased transparency regarding calls for service.
- Procure laptops for officers to use in the field or vehicles to access the University's camera system.
- Enhance the Muddox building windows to provide a safer environment for students, employees, and visitors.
- Purchase additional video surveillance cameras for parking lots and campus building coverage.
- Continue communications with the city of Sacramento and the Oak Park Business Association regarding issues or concerns in our area that may require attention.
- Continue officer training, education, and development regarding current issues in the community to ensure proper responses and the handling of sensitive, delicate, or volatile situations.

# 1 Department of Public Safety Authority and Jurisdiction Policy Statement

Department of Public Safety officers at the University of the Pacific, San Francisco campus are licensed security guards employed by the University. Each public safety officer possesses a professional license issued by the California Department of Consumer Affairs and has completed the requisite training and certification required for licensure. Public Safety Officers are empowered with private person's arrest authority pursuant to California Penal Code section 837. They are authorized to make arrests for any offense committed in his/her presence and for felony offenses not committed in his/her presence when there is reasonable cause for believing the person arrested committed the crime. San Francisco's Public Safety Officers are not sworn peace officers, and they do not have the authority to pursue crime off-campus. San Francisco's Public Safety Officers' jurisdiction is restricted to the facility located at 155 5<sup>th</sup> Street. San Francisco's Public Safety Officers are authorized to carry weapons while on duty. All officers maintain current California Department of Consumer Affairs, Bureau of Security and Investigative Services Guard permit, exposed firearms permit, chemical agents permit, and baton permit. Public Safety Officers have completed PC 832 Powers of arrest training.

All crimes reported to the Department of Public Safety are documented and, where appropriate, reported to the local San Francisco Police Department district or other appropriate law enforcement agency.

All students, faculty, and staff are strongly encouraged to make prompt and accurate reports of crimes to representatives from the Department of Public Safety. They are reminded of this during yearly orientation. Prompt and accurate reporting best equips Pacific to keep accurate records of criminal activity to determine whether there is a crime pattern concerning a particular location, method, or assailant, and alert the campus community to potential danger.

#### 2 Security and Access to Campus

The University of the Pacific, San Francisco campus is a private educational institution and access to its buildings and grounds are monitored by an access control system. The University of the Pacific, San Francisco campus (located at 155 Fifth Street, San Francisco, CA 94103) uses an access control system activated by personal ID badges issued to each student and Pacific

employee. All badges are worn on the outermost garment, attached above the waist with the picture visible. This serves to identify members to each other and to our patients and visitors. The absence of an ID badge quickly identifies a patient or visitor and expedites patient services.

The University of the Pacific, San Francisco campus provides general access to the University of the Pacific Community members and their guests between 6:30 a.m. and 11:00 p.m. during the academic week and between 6:30 a.m. and 9:00 p.m. on weekends and holidays.

There are armed Department of Public Safety officers on duty 24 hours a day. Security is further enhanced by extensive recorded camera coverage and alarm systems. Public Safety officers remain in the building after general access hours to ensure a continuing security and safety program.

The Union City Dental Care Center is an off-campus facility established to provide hands-on clinical training. The facility is operated in the same way as a professional clinic business. Faculty, staff, and students are identified by ID badge and the facility is protected during business hours by private security guards not affiliated with the Department of Public Safety.

The University of the Pacific, San Francisco campus strives for a safe campus along with security in our building. We can only do this with the help and cooperation of all faculty, staff and students.

Below are actions that should be practiced daily to ensure everyone's safety:

- Do not prop exterior doors; this allows for easy access to unwanted strangers.
- Do not hold the door for strangers.

## 5 Actions Taken in the Last 18 Months to Increase Safety and Security

The San Francisco campus continually looks to improve the safety of the campus. The Public Safety Advisory Committee continually evaluates the campus's security needs and identifies resources to resolve and security concerns. Over the past 18 months, the University has completed the following to increase security on campus:

- All new access cards provided to our campus community continue to include contact information for the University's Counselling and Psychological Services, National Suicide Prevention, Victim Advocacy and Title IX.
- A new secure bike/scooter cage with a card reader and camera surveillance was approved and has been installed and will be upgraded and completed later this school year.
- Hired two new officers to continue to provide safety and security for our campus community.
- Continue to partner with Office of Student Services to present virtual safety presentations.
- Department of Public Safety supervisors now registered with FEMA and will participate in education/training courses to enhance their skills in emergency management.
- Continue to provide virtual presentation to incoming classes and new employees.
- All officers were issued Cat-7 tourniquets for duty belt.
- Cat-7 tourniquets placed in all automated external defibrillator boxes throughout the campus
- During continued Pandemic operations, Department of Public Safety collaborates with several campus departments regarding clinic operations for patient care and for the resumption of classes.
- DPS patrol officers registered with FEMA and will participate in education and training courses to enhance skills in emergency management.

# 6 Actions Planned for the Next 24 Months to Increase Safety

- Updated de-escalation and diversity training will be provided to all members of the Department of Public Safety.
- Due to post-Covid protocols, changes to how student orientation and new employee safety presentations will continue to be implemented as new technologies emerge.
- An additional DPS patrol officer/staff person will be hired and assigned to the Union City Clinic.
- A new officer will be hired for the San Francisco Campus to provide for full staffing.
- Updated cameras are planned to be added to the system to provide for expanded campus coverage.
- A new emergency paging system utilizing updated technology is still in the process of being obtained to improve emergency medical response to our clinics.
- Collaborate with on-site medical response personnel to upgrade equipment and response protocols for medical emergencies (in process).
- The entrances to the campus and the clinics continue to be in the design phase and will enhance access control measures when completed.
- Collaborate with local and City-wide officials to increase campus community access to the City parking garage located across the alley.

## 1 Department of Public Safety Authority and Jurisdiction Policy Statement

The University of the Pacific operates under a "Memorandum of Understanding" ("MOU") with the City of Stockton which defines the authority and jurisdiction of all University of the Pacific Department of Public Safety peace officers. Since they are sworn peace officers and have been appointed City of Stockton peace officers under the MOU, all the University of the Pacific officers have the same powers and authority as any city, county, or state law enforcement officer. The powers include full arrest authority within their jurisdiction as provided by Penal Code section 830.6(a)(2) and the authority to carry weapons while on duty.

The University of the Pacific Department of Public Safety's primary responsibility is the protection of the University community. However, through the MOU, the Department of Public Safety has been granted jurisdiction to additional patrol and police specific off-campus areas in the u

University's vicinity. These areas are frequently traveled by members of the campus community and include residential neighborhoods that are highly populated by the University of the Pacific students, faculty, and staff. The current MOU extends the University of the Pacific Department of Public Safety officers' jurisdiction beyond the campus perimeter to the three city block area bordered by El Dorado Street, Rosemarie Lane, Bristol Avenue, and Grange Avenue that surrounds the University campus. Pursuant to Penal Code section 830.1(a)(2), all University of the Pacific Department of Public Safety officers have the authority to patrol and make arrests both on campus and within this additional jurisdictional area. In addition, University peace officers have the authority under California Penal Code section 830.1(a)(3) to pursue and/or apprehend suspects outside of these designated areas when there is probable cause to believe a public offense has been committed in the officer's presence and there is an immediate danger to person or property or the risk that the perpetrator will escape. Public Safety will respond to all emergency calls on or near the campus. Those calls that are determined to need extensive investigations (ie: homicides, sexual assaults, fatal accidents) will be handled by Stockton Police Department investigators.

The continuing goal of the University of the Pacific Department of Public Safety is to work cooperatively with the City of Stockton Police Department to ensure the safety and security of all campus community members. Please visit our website at:

#### 5 Actions Taken in the Last 18 Months to Increase Safety

The University of Pacific continually looks to improve the safety of the campus. The Campus Safety and Security Committee continually evaluates the campus's security needs and identifies resources to resolve any security concerns. Over the past 18 months, the University has completed the following to increase security on campus.

- Began a surveillance camera refresh program to replace 75 cameras.
- Public Safety purchased several U-locks for students to lock their bikes.
- Purchased two radar signs to warn drivers of speed.
- Added two cameras to our surveillance system.
- Created an emergency go bag containing a phone, computer, and other supplies for Dispatch.
- Met with City of Stockton to develop a traffic plan around the campus.

#### Actions Planned in the Next 24 Months to Increase 6 Safety

- Add a live scan system for employment and certifications
- Create a long-term strategic plan for the department.
- Improvement of Public Safety's Record Management System.

- Install camera surveillance software in patrol vehicles.
- Program cameras to auto-track emergencies.
- Impliment a virtual parking permit system.
- Obtain access to the City of Stockton camera system.
- Take over dispatching for the Sacramento campus.
- Emergency Management Team training.
