Second, such gifts normally allow the donor to avoid the capital gains tax otherwise payable on the appreciation in the value of the securities being given.

# **DTC or Electronic Transfer Instructions**

Electronic, or DTC transfer, is the fastest and most secure method of donating securities. Please instruct your broker to transfer the securities to one of Pacific's brokerage accounts listed below.

Donors making gifts at the end of the year should confirm with their broker that the transfer will be completed on or before December 31st.

### **Transfer of Mutual Funds**

Unlike securities, transferring ownership of a mutual fund can be a slow and manual process. The re-registration process time varies from fund to fund and can take as long as six to eight weeks. Please instruct your broker to transfer the mutual funds to one of Pacific's brokerage accounts listed below.

Donors making gifts at the end of the year should begin this process six to eight weeks before the end of the year and confirm with their broker the transfer will be completed on or before December 31st.
