

SUMMER 2022

The Summer 2022 term is a part of the 2021-2022 school year. Any loans borrowed or Pell Grant awarded in Summer 2021, Fall 2021 or Spring 2022 will reduce the amount of aid you are eligible for during the Summer 2022 term.

ENTERING STUDENTS

Graduate and Teaching Credential Students:
You must be admitted *effective summer 2022* as a degree or credential candidate to qualify for summer aid. Also, before determining your eligibility, we must have:

- Your 2021-22 FAFSA information from the federal student aid processor.
- If selected for Federal Verification, you and/or your parents must complete and submit all requested verification documents through “Verify My FAFSA.”

Freshmen, transfer and Return to Active Status Students entering in Fall 2022 are not eligible for aid this summer.

CONTINUING PACIFIC STUDENTS

Students who are academically disqualified (DQ) or subject to disqualification (SQ) cannot receive financial aid.

- If selected for Federal Verification, you and/or your parents must complete and submit all requested verification documents through “Verify My FAFSA.”

DPT, SLP, Evening/Off-Campus Programs, and DH Class of '23: Do not fill out this worksheet. Summer will be included in your 2021-22 award.

MINIMUM ENROLLMENT: HALF-TIME

Undergraduates and teaching credential students must enroll for at least 6 units, total, in one or more sessions. For master's and doctoral students, the minimum is 4 units.

HOW TO APPLY

You must complete a 2021-22 FAFSA (Free Application for Federal Student Aid) to be considered for Summer Financial Aid.

■ **MEET WITH YOUR ADVISOR** and decide what courses you need to take.

■ **REGISTER** for all your summer classes.

Fill out Section I of the **Summer 2022 Worksheet**.

NOTE: The information on your worksheet (*units per session*) must match your actual registration in order for your summer aid application to be processed.

■ **EMAIL YOUR COMPLETED WORKSHEET** to the Financial Aid Office at financialaid@pacific.edu.

You will be contacted at your **Pacific e-mail** address if more documentation is required and/or your worksheet has been processed. Instructions on how to accept your aid will be included.

■ **DON'T CHANGE YOUR MIND!**

Summer sessions are short and there is little time to make corrections. If your plans change and your worksheet has to be re-done, you might lose access to summer aid.

If you don't attend all the classes for which your financial aid is processed, your aid may be reduced or cancelled.

- Federal Direct FORD Loans
- Federal Direct PLUS & Grad PLUS Loans
- Federal Pell Grant

If you have *Cal Grant* eligibility remaining after spring semester and you will graduate in August or December 2022, you can apply for Summer Cal Grant benefits. Please see a counselor for details.
